## NOTES

- 1 If you are an ordinary member of the Trust, you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote at the Annual General Meeting of the Trust.
- 2 To be valid, this form of proxy must be completed and signed (electronically is acceptable) and returned to the Trust either (a) in hard copy to Aberfeldy Development Trust, Locus Centre, Aberfeldy PH15 2D or (b) by e-mail to [aberfeldydevelopmenttrust@gmail.com](mailto:aberfeldydevelopmenttrust@gmail.com) in each case to be received by the Trust not less than 48 hours before the time for holding the Annual General Meeting.
- 3 A proxy does not need to be a member of the Trust but must attend the Annual General Meeting to represent you. To appoint as your proxy a person other than the Chair of the Annual General Meeting, insert their full name in the box. If you sign and return this proxy form with no name inserted in the box, the Chair of the Annual General Meeting will be deemed to be your proxy. Where you appoint as your proxy someone other than the Chair, you are responsible for ensuring that they attend the Annual General Meeting and are aware of your voting intentions.
- 4 To direct your proxy how to vote on the resolutions mark the appropriate box with an "X". If no voting indication is given, your proxy will vote or abstain from voting at their discretion. Your proxy will vote (or abstain from voting) as they think fit in relation to any other matter which is put before the Annual General Meeting.
